 - c. 1x photocopy each of CNIC of each i.e. donor & donee.
 - d. Two attested photographs of the transferee/donee.
 - e. Original Allotment Order/Transfer Order/Division Order etc to be returned for cancellation.
 - f. Undertaking for Loan Mortgage of Plot by Donor.
 - g. In case of Hiba of plot in the name of more than one owner, a consent letter from all the cosharers be attached, indicating/mentioning the address on which the correspondence is to be made.
 - h. GHQ NOC, in case of transfer by Armed Forces allottee officer (serving/retired), allotted by GHQ.
- 2. Ensure all dues on the plot are cleared.
- 3. After 'Sign Before' on the transfer documents, the Designated Officer will return the documents to the Donor (Transferor).
- 4. The Donee (Transferee) to pay the transfer fee in the Account Branch (1st Floor). The Account Branch will make necessary endorsement on the covering letter.
- 5. The donee (Transferee) to deposit the Transfer Documents at the Reception (veranda) and obtain a receipt. The receipt will indicate the date of collection.

- 2. Before making out a Pay Order/Bank Draft please find out the outstanding dues and current rate of Fee from Accounts Branch.
- 3. In case you desire your case to be processed on urgent basis, on payment of requisite emergent fee, please contact the Director/Addl Directors for necessary endorsement before paying the fees/submitting the documents at the counter reception.
